Project was issued for bid in October

- Ten Bidders were Pre-Qualified for the Project
 - Monterey Mechanical
 - Overaa Construction
 - Walsh Construction
 - Flatiron Corporation
 - PCL Construction
 - Kiewit
 - Shimmick Construction
 - Western Water Constructors
 - W. M. Lyles
 - GSE Construction

A mandatory job walk was held on October 22nd

- Eight of the ten bidders were present for the job walk:
 - Monterey Mechanical
 - Overaa Construction
 - Walsh Construction
 - Flatiron Corporation
 - Kiewit
 - Shimmick Construction
 - Western Water Constructors
 - W. M. Lyles
- The two bidders not present were contacted have declined to bid the project due to other commitments.


Current Status:

- We are accepting and responding to questions from bidders
 - First addenda was issued this week
 - A second addenda is being prepared from additional questions that have been submitted by contractors.
- The deadline for questions is Wednesday November 25th.
- Bids are scheduled to be opened December 10, 2015.

Activities After Bid Opening

- Internal review of bid to determine if the low bid is responsible and responsive.
- Submittal of bid documents to State Revolving Fund for review and approval.
- Award of Bid and issuance of Notice to Proceed.
- Current estimated start of actual construction is March 2016.
