### 8. PUBLIC HEARINGS

A. Introduced and Conducted First Reading of an Ordinance Adding Chapter 8.35 to the Pinole Municipal Code to Regulate Loud, Unnecessary, or Unusual Noise In the City of Pinole

[Action: Approve 1st Reading Per Staff Recommendation (Reyes/Casher)]

Eric Casher from the City Attorney's office presented the report and provided an overview of the proposed noise ordinance. The Ordinance adds Chapter 8.35 to the Pinole Municipal Code to regulate loud, unnecessary, or unusual noise in the City of Pinole. Violation of the ordinance is an infraction subject to fine, and continued violation is a nuisance subject to abatement.

At 7:36 pm, Mayor Long opened the Public Hearing. City Manager Fitzer read into the record an email comment from Kimberley Bautista in favor of the ordinance and having no additional speakers, at 7:37: pm, Mayor Long closed the Public Hearing.

ACTION: Motion by Council Members Toms/Banuelos to introduce and conduct a first reading of a proposed ordinance to add Chapter 8.35 to the Pinole Municipal Code to regulate loud, unnecessary or unusual noise in the City of Pinole.

B. Introduced and Conducted First Reading of an Ordinance Amending Chapter 8.30 and Adding Chapter 8.36 to the Pinole Municipal Code to Require Balcony Inspections In the City of Pinole

[Action: Approve 1st Reading Per Staff Recommendation (Reyes/Casher)]

Eric Casher from the City Attorney's office presented the report and provided an overview of the proposed balcony inspection ordinance. Under the ordinance amending Chapter 8.30, prior to the City's issuance of a certificate of compliance, a rental property owner must have a licensed professional inspect any existing balcony to verify balcony safety. Under the ordinance adding Chapter 8.36, prior to the City's issuance of a certificate of compliance at the time of any real property sale, the owner must have a licensed professional inspect any existing balcony to verify balcony safety.

The addition of Chapter 8.36 creates a balcony inspection requirement at the point of sale for real property in the City of Pinole prior to the City's issuance of a certificate of compliance.

Mr. Casher stated that Senate Bill 721, introduced by Senator Jerry Hill, was recently amended on April 27, 2017, and would require balcony inspection for all buildings containing 3 or more units. Inspection and repairs must be complete by January 2021 with subsequent inspections every 5 years.

Councilmember Swearingen and Mayor Pro Tem Banuelos stated their support for balcony inspections, changing from 10 years to 5 years, at point of sale.

Councilmember Murray requested that the wording for the inspection work be amended to reflect that the inspector must be licensed and bonded.

Councilmember Toms stated her support for balcony inspections to be performed every 5 years.

Mayor Long requested clarification on the definition of a balcony versus a deck. Attorney Casher stated that verbiage can be changed for a clear definition of deck and balcony. Mayor Long also stated her support for balcony inspections every 5 years. She questioned the process of sale and escrow holdings prior to purchase. City Attorney Reyes stated that the City would require a balcony inspection similar to the sewer lateral inspection.

At 8:16 pm, Mayor Long opened the Public Hearing, and having no speakers, at 8:16 pm, Mayor Long closed the Public Hearing.

ACTION: Motion by Council Members Toms/Banuelos to introduce and conduct a first reading of a proposed ordinance to amend Chapter 8.30 and add Chapter 8.36 to the Pinole Municipal Code to require balcony inspections in the City of Pinole with a modification to Chapter 8.36.080 balcony compliance and issuance of certificate of compliance from 10 years to 5 years.

City Manager Fitzer presented the report to Council and stated that the City of San Pablo will take the lead on the CAD/RMS services. This agreement will nullify the Hercules agreement for dispatch services. The City of San Pablo will be contributing 19% of the Hercules contribution; and Hercules will repay the City of San Pablo. City Manager Fitzer stated that the resolution was revised to include pertinent language. Council asked questions and received responses.

ACTION: Motion by Council Members Murray/Banuelos to approve a Tri-City Police Dispatch Services and CAD/RMS agreement between the cities of Pinole, Hercules and San Pablo, and authorize the City Manager to execute the agreement.

Mayor Long requested a brief report on progress being made on CHP and Caltrans for camera installation along the I80 corridor. Chief Gang stated that funding has been received for Highway 4 and I80 corridors.
