8. PUBLIC HEARINGS

A. Introduction and First Reading of an Ordinance amending Chapter 8.20 of the Pinole Municipal Code Regarding Stormwater Management and Discharge Control, and Imposing New Pollutant Discharge Requirements

[Action: Approve First Reading Per Staff Recommendation (E. Casher)]

City Attorney Casher presented the report and informed Council that in order to comply with the San Francisco Bay Region's Municipal Regional Stormwater NPDES Permit (the MRP Permit), the proposed ordinance amends the Municipal Code to require that all inlets to the storm water system located in any parking lot or certain other paved areas in the City have trash capture devices installed.

Council asked questions and Community Development Director/City Engineer Tamara Miller provided responses. She informed Council that Caltrans is actively participating with municipalities to assist with trash control efforts along the corridor. Mayor Long suggested partnering with Republic Services for litter mitigation efforts throughout the City.

At 7:58 p.m., Mayor Long opened the Public Hearing, and having no speakers, at 7:58 p.m., Mayor Long closed the Public Hearing.

Planning Manager Winston Rhodes presented the report and stated that the proposed text amendment is intended to correct the current internal Zoning Code inconsistency between Chapter 17.20 and Chapter 17.59. The zoning code changes will ensure compliance with state law regulating alcohol sales at gas stations. The Municipal Code Update Subcommittee, comprised of Councilmember Toms and Mayor Pro Tem Banuelos, reviewed and support the changes to resolve the internal zoning code inconsistency. Council asked questions and received responses.

City Manager Fitzer presented the report and stated that the Utility Users Tax (UUT) is vital funding source that needs to be renewed and secured. She recommended adding UUT to the General Election ballot November 2018, asking voters to renew the UUT without any sunset. Council expressed their support.

City Manager Fitzer announced that Marin Clean Energy (MCE) has sent the City a letter asking to form the Community Leader Advisory Group (CLAG). MCE is soliciting community members to apply for the committee. CLAG members advise MCE on community outreach strategies and identify venues for reaching broad section of energy consumers.
