At 7:16 p.m., Mayor Long reconvened the meeting in open session and announced there were NO REPORTABLE ACTIONS

5. RECOGNITIONS / PRESENTATIONS / COMMUNITY EVENTS

A. Proclamations

a. Proclamation declaring November as Homelessness Awareness Month

Mayor Long presented the proclamation to Jenny Robbins, Housing and Services Administrator Health, Housing and Homeless Services. Ms. Robbins is a resident of Pinole and employee of Contra Costa County and honored to receive the proclamation on behalf of the County. Point and Time Count, federal initiative coming up and soliciting volunteers.

B. Presentations / Recognitions

 Board member Mister Phillips of the West Contra Costa Unified School District will provide an update on District programs such as the new Positive School Climate Policy

Board member Mister Phillips of the West Contra Costa Unified School District provided an update to Council on the current task of reforming school discipline. The district created the Willful Defiance Task Force to research the issue and come up with a recommendation to the board, addressing the willful defiance suspension. The committee included the School Resource Officer's (SRO's) were included in the policy brought forward for Board approval. The policy was approved by the Board. Board member Phillips stated his support for community involvement in the decision and implementation of Restorative Justice including teachers and students to enable them to navigate the district. He restated his concern with the removal of SRO's due to impact.

Mayor Long stated her support of the positive school climate program and her concern about the removal of the SRO's. She stated that the policy states that the funds for the SRO's will be

redirected for school programs. Mayor Long expressed her disappointment with the District's Board members and their lack of desire to form partnership with the City. She stated her concern about student safety and defiance, the City will no longer have the partnership with the school district and the City will enforce the law to make the City of Pinole safe.

Board member Phillips stated that in order for the District to be successful it requires strong partnerships with the City. The District depends on the city for multiple projects and relationships. Discussions moving forward will include student, parents and teachers for their input. You can't make policies that deal with law enforcement in isolation. The ban is to remove suspension solely for "willful defiance", students will still be suspended. The policy does not go into effective immediately; it will be phased in i.e., 2018 into effect for elementary, 2019 middle school and high school implementation. He is not in support of removing the SRO's from the District. The policy was not intended to remove the SRO's, the Superintendent is in support of removing the discussion of SRO's. The District must have high functioning teachers in order to be a high functioning district.

Mayor Pro Tem Banuelos stated his discontent in the manner in which the Board meeting was conducted and the disrespectful manner in which community members and elected officials were treated.

Councilmember Swearingen stated his support for implementing the restorative justice approach in addition to keeping the SRO's. He stated his concern with child safety due to recent incidents involving crime against children on school sites.

Councilmember Murray thanked Board member Philips for being present and stated his concern with the new discipline policy.

Councilmember Toms stated that the District runs the risk of losing students due to disruptions and unsafe conditions in the school. She encouraged members of the community and parents to attend the next school board meeting on December 6, 2017 to state their concern.

Council thanked Board member Phillips for coming to the City and presenting an update with current policies. He is willing to come and speak to the Council on issues.
