PINOLE CITY COUNCIL MINUTES April 17, 2018

The Regular Pinole City Council Meeting was held in the Pinole Council Chambers, 2131 Pear Street, Pinole, California. Mayor Banuelos called the Regular Meeting of the City Council to order at 6:01 p.m. and led the Pledge of Allegiance.

At 7:09 p.m., Mayor Banuelos reconvened the meeting in open session and announced there were NO REPORTABLE ACTIONS.

 - A. Presentation by Matthew Duffy, WCCUSD Superintendent

Superintendent Mathew Duffy provided an overview of the District's five year roadmap and Pinole schools. The district is stabilizing and seeing a small increase in student enrolment. He discussed charter expansion and stated that the district must provide site(s) to a charter school (under Proposition 39) upon their request, with a one year facilities agreement. The District considers the school sites that are under capacity as potential facilities. Mr. Duffy informed the community of the upcoming public hearing in San Pablo to discuss redistricting of the District and that it will be an item for voter approval. Council asked questions and received responses.

The following speaker addressed the City Council:

Anthony Gutierrez, resident of Pinole, inquired on student acceptance rates, recruitment of STEM teachers throughout the District and state funding appropriation for future facility repairs. Mr. Duffy provided a response to the questions presented.

6. CITIZENS TO BE HEARD (Public Comments)

<u>Jack Meehan</u>, resident of Pinole, stated his appreciation to the Fire Service personnel, whose motto should be "on my honor I will do my best".

Bob Kopp, resident of Pinole, invited Council and the community to attend the Community Service Day on Saturday, June 2, 2018 at 8:00 a.m., continental style breakfast and lunch at 11:00 a.m. The Pinole Car Show is scheduled for Saturday, June 24, 2018.

Franke Martinez, resident of Pinole, thanked Council for their time and commitment to the community and stated his opposition to Measure P and his concern with the cost associated to place the measure on the ballot.

<u>Jeff Rubin</u>, resident of Pinole, stated his support of Measure P to repeal Term Limits.

<u>David Ruport</u>, resident of Pinole, stated his opposition to Measure P and provided an update on the efforts done opposing the measure.

<u>James Tillman</u>, resident of Pinole, inquired about the City's representation on ABAG and funding opportunities.

William Horton, resident of Pinole, stated his support of Measure P.

Mary Horton, resident of Pinole, stated her support of Measure P.

<u>Anthony Gutierrez</u>, resident of Pinole, stated his opposition to Measure P and provided clarification to comments made at a previous Council meeting.

8. PUBLIC HEARINGS

A. Introduction and First Reading of an Ordinance Adding Chapter 12.36 to the Pinole Municipal Code Regarding Responsibility of Property Owner for Maintenance of Adjacent Sidewalk

[Action: Approve First Reading per Staff Recommendation (E. Casher)]

City Attorney Eric Casher presented the report and provided a power point presentation of the proposed ordinance. Development Services Director/City Engineer Miller provided responses to some of the questions presented.

Councilmember Long inquired about the ownership and responsibility of sidewalk maintenance and damages/lifts to sidewalk caused by earth movement, trees in front yard resulting in damage to adjacent property sidewalks. She stated her concern with the proposed timeline, permit process, permit fees and the financial implications to property owners.

Mayor Pro Tem Murray inquired about assistance programs available for property owners in neighboring cities with established sidewalk ordinances and the requirements for property owners to obtain insurance coverage for future repairs. He supports a fee waiver to assist homeowners in making sidewalk repairs.

Councilmember Toms inquired about homeowner responsibility for sidewalk algae caused by water runoff/drainage. City Attorney Casher stated that this would be considered a dangerous condition and the responsibility of the property owner.

At 9:09 pm, Mayor Banuelos opened the Public Hearing, and the following speakers addressed Council:

David Ruport, resident of Pinole, inquired about potential legal repercussions against property owners and presented several questions.

James Tillman, resident of Pinole, stated his concern on the proposed ordinance and inquired about property owner responsibilities.

Brandon Cody, resident of Pinole, inquired about potential legal repercussions against property owners and requested specifications on sidewalk repairs. He presented additional questions.

Anthony Gutierrez, resident of Pinole, inquired about past practice of sidewalk repairs. He suggested the City adopt a sidewalk ordinance similar to the Sewer Lateral Replacement program, which requires inspection at point of sale, for low income and senior citizens of the community. He presented additional questions for Council review.

Bill Low, resident of Pinole, inquired about rolling curbs in certain neighborhoods and requested clarification of what constitutes a sidewalk.

Jack Meehan, resident of Pinole, requested clarification on the definition of sidewalk and the perimeters of the sidewalk within neighborhoods. He inquired as to the purpose of the ordinance and the fiscal impact to the City.

City Attorney Casher and Development Services Director/City Engineer Miller provided responses to some of the questions presented by the speakers and Council.

Topics for subcommittee's review: Notification to all property owners, waive encroachment fees. continuance of the City's grinding program (funded by the City), senior citizen financial assistance repair program, point of sale inspection, assistance in organizing neighborhood meetings to discuss issues, clear definition of parameters, sharing cost between homeowner and City; and notification of dangerous situations via certified mail. The proposed ordinance does not shift liability from the City to the homeowner; the liability already exists according to the law.

Having no additional speakers, at 9:32 pm, Mayor Banuelos closed the Public Hearing.
