ITEMS OF INTEREST

• COUNCIL APPROVES NEW FIRE SERVICE DELIVERY STUDY

At the January 22nd workshop the City Council approved moving forward with a new consultant study of Pinole's Fire Services. The study will include option such as Pinole Fire re-opening Station 74; contracting for services with Contra Costa Consolidated Fire Protection District; contracting or consolidating with Rodeo/Hercules Fire District; and what would it take for Pinole Fire to be a fully functional stand alone department. The Request for Proposal (RFP) was published on January 30th, with responses due back on February 25th. The anticipated report submittal is August 20th, but we will know more once we receive proposals for the project and start discussing the scope of work to be completed. Community meetings will be scheduled to present and discuss the report findings, and receive input on desire next steps. Much more to come on this topic...

THERAPY DOG PROGRAM COMING TO THE PINOLE POLICE DEPARTMENT

Milo will be joining our Community Outreach Unit along with Community Outreach Officer Witschi. Community Outreach Officer Witschi will be attending a handler academy in March to meet and receive her new partner.

Milo and Community Outreach Officer Witschi will be assisting with calls such as: traumatized persons, forensic interviews, witnesses of crimes, first responders who have witnessed or experienced a traumatic event, elderly citizens in crisis, mental health issues, child neglect/abuse, sexual abuse/assault, and death notifications.

We hope you will join us in our excitement of bringing this much needed program to Pinole Police Department and to the community.

The City is recruiting to fill vacancies on the following boards and commissions! If you are a citizen interested in community service in a variety of disciplines, there are several opportunities available. These vacancies will remain *open until filled*:

Planning Commission (2 positions):

The Pinole Planning Commission is a seven-member panel of Pinole residents who take action on development requests and make policy recommendations to the City Council. The Commission usually meets on the 4th Monday of every month at 7:00 pm in the City Council Chamber, although additional meetings may be called as required. Commissioners serve four-year terms.

Community Services Commission (3 positions):

The Pinole Community Services Commission seeks to enhance quality of life for the citizens of Pinole through responsive and interactive community services. A critical aspect of the Commission is their community advocacy. They provide feedback for a number of organizations and projects. The Commission also weighed in on issues such as the Skate Park, Swim Center, No Smoking in Parks policy and exploration of the Charter School concept. Commissioners regularly talk to community members and bring ideas back to the Commission and Recreation Department on what our community needs and wants. http://www.ci.pinole.ca.us/play/csc.html

Traffic and Pedestrian Safety Committee (1 position)

The Pinole Traffic and Pedestrian Safety Committee is a five member panel who recommend or review action on traffic safety, traffic control and planning, speed limits, parking and other traffic related matters. The committee makes recommendations to the City Council; committee members service two-year terms.

Contra Costa Library Commission (1 position - 2-year term as Alternate Delegate):

The Contra Costa County Library Commission was established by the Contra Costa County Board of Supervisors in March 1991. The Commission was created (March 1991) to serve in an advisory capacity to the Board of Supervisors and the County Librarian. The Library Commission is comprised of 24 members:

- 18 members representing the cities/towns in Contra Costa County these Commissioners are appointed by the city/town councils (Richmond does not participate)
- 5 members represent Contra Costa County each member of the Board of Supervisors appoints one Commissioner
- 1 member representing the Central Labor Council.

Currently the Commission meets every other month, on the fourth Thursday evening at 7:00 p.m. at the Library Administration in Martinez http://guides.ccclib.org/Commission.

Contra Costa County Advisory Council on Aging (1 position):

The Contra Costa County Advisory Council on Aging (ACOA) is appointed by the Board of Supervisors to advise them on all matters associated with the planning, development and administration of programs relating to older adults. The ACOA consists of forty (40) members. Fifty percent (50%) of the ACOA must be age 60 and above.

Currently the ACOA meets on the third Wednesday of each month, 9:30 a.m. – 11:30 a.m. at 500 Ellinwood Way, Pleasant Hill in Board Rooms A & B. Please submit your **Letter of Interest** and/or an application or additional information.

New Compost Giveaway Program

Republic Services is providing a new opportunity for the West Contra Costa community to receive free compost. Close the loop on your organics recycling by using the finished compost made right here in Richmond. Starting February 6th and each 1st Wednesday of the month thereafter, West County households can come to WCRR located at 101 Pittsburg Avenue, Richmond from 9am - 4pm and get up to 2 cubic yards of compost per month.

This compost is great for gardens and landscaping. This is self-service only so please BYOB (Bring Your Own bag, bin or bucket) and shovel to load the material. Valid identification is required.



Say Bye Bye to Your Old Mattress

Republic Services has teamed up with Bye Bye Mattress, *A Program of the Mattress Recycling Council*, to provide a collection site for old unwanted mattresses or box springs. Starting February 1, 2019, households in the cities of Richmond, Hercules, Pinole, San Pablo, El Cerrito and unincorporated communities (including Alhambra Valley-west side, Bayview, East Richmond Heights, North Richmond, Rollingwood and Tara Hills of Montalvin, El Sobrante) are eligible to bring 3 items per month to be recycled. Businesses are not allowed to use this collection site but can bring them to the Golden Bear Transfer Station (1 Parr Blvd. Richmondfees apply). We can only accept whole items. No excessively wet, damaged, partial or soiled mattresses or mattresses with bed bugs. We do not accept car beds, fold out sofa beds and futons, waterbeds, air mattresses, sleeping bags, pillows, mattress toppers or other furniture.

Mattresses can be dropped off Wednesday – Saturday 9am-4pm at 101 Pittsburg Avenue, Richmond. Please bring proper identification or utility bill with address of household generating the items. Visit www.richmondsanitaryservice.com for more information.

Erosion Control, Naturally

The California Urban Streams Partnership promotes soil bioengineering — a biotechnical technique that uses a combination of plant materials and soil to accomplish the following: bank stabilization, erosion control, improved habitat and water quality. It combines structural and ecological methods recommended in federal engineering manuals. This approach has many benefits over "traditional" erosion control methods. Some additional benefits include:

- Cost Effectiveness: Willow cuttings can be locally harvested. Many of these techniques can be performed by the homeowner. Soil bioengineering is much cheaper when compared against long-term maintenance and lifespan replacement costs associated with traditional structural solutions such as riprap and concrete.
- Long-term Stability: Planting riparian
 vegetation can offer the best long-term
 protection against erosion. The roots have a
 similar or greater tensile strength than concrete
 and absorb the stream's erosive energy without
 deflecting the problem to another section of
 channel. Fast rooting riparian vegetation
 quickly provides structure and stability to a
 slope and controls channel incision.
- Improved Habitat for Local Flora and Fauna:
 Riparian plants provide food and shelter for birds and wildlife. Furthermore, once established, trees grow into a riparian canopy that keeps water temperatures cool, allowing stream life to thrive.
- Highly Encouraged by Regulatory Community:
 These techniques are often required by permitting agencies like CA Fish and Wildlife and the San Francisco Bay Water Quality
 Control Board

<u>A typical problem</u> experienced by streamside properties is bank erosion.

Below is an example employing two commonly applied soil bioengineering techniques: brushlayering and live staking to replace failing concrete banks.

Zone A: Edge of active channel, at toe of slope to mid-bank.

Zone B: Mid-bank to top of bank.

Some Zone B Plants:

- Willows

- Dogwood
- Ninebark
- Native Blackberry

Zone C: Top of Terrace.

Some Zone C Plants:

- California Sycamore
- Oaks
- Big Leaf Maple
- California Buckeye
- Toyon
- Coyote Bush
- Wild Rose

What SMPL can do for you:

If you are a Contra Costa County resident with a creek on the property, these services are available to you at no charge.

• Site Visit and Consultation:

California Urban Streams Partnership staff will provide a site evaluation and advice on how to address issues such as creek bank failure, erosion, and flooding.

• Neighborhood Workshops:

Your actions can change the condition of your creek upstream, downstream, and across from your property. CUSP can provide hands-on, local workshops.

Learning and working with your neighbors can ensure a coordinated effort that works for everyone!

• Technical Advice:

CUSP staff will provide information on restoration techniques you can implement. We can also direct you to qualified local engineers, landscape architects, and other related consultants and contractors. In some circumstances, technical advice and assistance may be available from the Contra Costa County Resources Conservation District or Natural Resources Conservation Services.

• Restoration Project Permitting:

Restoration projects must meet federal, state and local agency regulations in the form of permits. CUSP will provide information on the regulatory process.

• Community Presentations:

Is your neighborhood interested in learning about your creek? CUSP can provide a night or weekend presentation on common creeks problems, including successful and inexpensive solutions.

California Urban Streams Partnership

• The California Urban Streams Partnership is an organization of local, regional and statewide groups which protect, restore and steward urban streams. CUSP works to increase the quality of city life and neighborhoods and return functioning ecosystems for fish, birds and wildlife to urban environments. An important part of this mission is to reduce creek erosion and flooding problems so that creeks are neighborhood amenities. The directors and advisors of the California Urban Streams Partnership have over a 35 year history (since 1982) of pioneering in organizing, funding, designing, constructing and evaluating urban stream restoration projects. This history successfully demonstrates the replacement of conventional engineering using concrete and rock channels with innovative restoration project designs that rely on natural processes, including daylighting creeks from culverts.
