• <u>FIRE SERVICES DELIVERY STUDY DRAFT REPORT PRESENTATION –</u> OCTOBER 8TH

As noted above, the consultants performing the Fire Services Delivery Study will be providing the Council and Community with their presentation of their findings and recommendations. The presentation will be held on Tuesday, October 8th at 6:00 pm in the Council Chamber.

The consultants have been analyzing Pinole Fire as we operate today, and evaluating what options we have for potential enhancements to our service delivery model. Options include the City re-opening Station 74 and Pinole Fire operating from both Stations; as well as the City re-opening Station 74 and Contra Costa County Fire Protection District operating both stations.

The Council is very interested in hearing from the Community about your interest in Fire services and the potential to re-open Station 74. A parcel tax measure is being discussed by the City and may appear on the November 2020 ballot. Now is the time to make your voice heard, as it is important that the Council know what the Community as a whole would like to see with regard to Fire services, and what we are willing to pay for them.

GET INVOLVED! JOIN A CITY BOARD, COMMITTEE OR COMMISSION!

The City is recruiting to fill vacancies on the following boards and commissions. If you are a citizen interested in community service in a variety of disciplines, there are several opportunities available. These vacancies will remain *open until filled*:

Traffic and Pedestrian Safety Committee (1 position)

The Pinole Traffic and Pedestrian Safety Committee is a five member panel who recommend or review action on traffic safety, traffic control and planning, speed limits, parking and other traffic related matters. The committee makes recommendations to the City Council; committee members service two-year terms.

Contra Costa Library Commission (1 position - 2-year term as Alternate Delegate):

The Contra Costa County Library Commission was established by the Contra Costa County Board of Supervisors in March 1991. The Commission was created (March 1991) to serve in an advisory capacity to the Board of Supervisors and the County Librarian. The Library Commission is comprised of 24 members:

- 18 members representing the cities/towns in Contra Costa County these Commissioners are appointed by the city/town councils (Richmond does not participate)
- 5 members represent Contra Costa County each member of the Board of Supervisors appoints one Commissioner
- 1 member representing the Central Labor Council.

Currently the Commission meets every other month, on the fourth Thursday evening at 7:00 pm at the Library Administration in Martinez http://guides.ccclib.org/Commission.

Contra Costa County Advisory Council on Aging (1 position):

The Contra Costa County Advisory Council on Aging (ACOA) is appointed by the Board of Supervisors to advise them on all matters associated with the planning, development and administration of programs relating to older adults. The ACOA consists of forty (40) members. Fifty percent (50%) of the ACOA must be age 60 and above.

Currently the ACOA meets on the third Wednesday of each month, 9:30 a.m. – 11:30 a.m. at 500 Ellinwood Way, Pleasant Hill in Board Rooms A & B. Please submit your **Letter of Interest** and/or an application or additional information.

Napa County Solar Project Powers 1,000+ Homes Per Year



MCE and Renewable Properties celebrated the completion of MCE's first local, renewable energy project in Napa County in August with a ribbon cutting for the American Canyon Solar Project, one of the largest solar farms in Napa County. The annual 3 MW output from the project is expected to generate enough clean, locally-produced electricity to power over 1,000 homes per year. MCE Rooftop Solar Customers Offered \$2.8+ Million in Cash Back



MCE is issuing cash outs totaling over \$2.8 million to rooftop solar customers when they have produced more electricity than they used themselves. MCE's <u>Net Energy Metering</u> (NEM) program currently provides incentives for rooftop solar customers, including paying premium rates that compensate solar customers at the full retail rate plus an extra penny per kilowatt-hour for excess electricity generated.

Deep Green Campaign

MCE launched a geo-targeted digital ad campaign on August 1st, encouraging people to opt up to Deep Green 100% renewable energy. The ad campaign is one component of a multi-faceted Deep Green Opt Up effort that will also include targeted outreach and marketing to top commercial customers, partners and advocates, Chambers of Commerce, municipalities, electric vehicle drivers, and employees of Bay Area businesses, organizations, and agencies that have opted up their commercial accounts to 100% renewable with their respective CCA (see Employee Upgrade Challenge above). MCE's goal is to double our number of Deep Green accounts to 20,000.
