B. Approve the Recognized Obligation Payment Schedule (ROPS 16-17) For July 1, 2016 to June 30, 2017 in the Amount of \$3,636,311 [OB Report No. 2016-01; Action: Adopt Resolution Per Staff Recommendation (Miller)]

Andrea Miller, Finance Director presented Oversight Board Report 2016-01 into the record, recommending adoption of a resolution approving the Recognized Obligation Payment Schedule (ROPS) pursuant to Part M of Section 34177 of the Health and Safety code for the time period of July 1, 2016 through June 30, 2017 in the amount of \$3,336,011. All agencies are required to submit a ROPS by February 1, 2016 and every February 1 thereafter. Finance Director Miller drew the Board's attention to Item 45-and 26 which are the semi-annual Tax Allocation Bond principal and interest payable August 1, 2016 and February 1, 2017. All other items were consistent with the ROPS schedules previously submitted. Ms. Miller was available for questions.
