E. PUBLIC HEARINGS:

1. **Conditional Use Permit 16-11 and Design Review 16-36: Famiglia Italian Restaurant , Alcohol Sales, Outdoor Dining, and Signage**

Request:

Consideration of a use permit request for on-site alcohol sales in conjunction with an approximately 3,455 square foot restaurant within a vacant portion of an existing approximately 16,337 square foot commercial building including operation of an additional approximately 646 square foot outdoor dining area and a design review request for new exterior signage.

1
2 On behalf of the applicants, Ms. Haro identified the location of the patio in the front
3 of the building fronting San Pablo Avenue adjacent to the Fitness Studio, and
4 reported that tenant was in support of the application. She confirmed the
5 applicants had not obtained approval from the Pinole Shores Owners Association
6 because they wanted to obtain approval from the Planning Commission first, and
7 then approach the Pinole Shores Owners Association to request outdoor dining
8 and alcohol sales. She asked whether the applicants would be required to pay
9 additional fees if they returned with such a request.

10
11 Mr. Rhodes advised that the applicants would be required to pay half the cost of
12 the CUP to amend the CUP. He emphasized the City would not consider a
13 proposed use absent the property owner's consent. The fee would be lower for a
14 request just for outdoor dining without alcohol sales since it would not require
15 Planning Commission approval and would be handled through a Zoning
16 Administrator hearing. If a request for outdoor dining was to be made in the future,
17 there would be a discussion as to how to address the loss of landscaping, which
18 had been a condition when the Business Park had originally been built.

20 **PUBLIC HEARING CLOSED**

21
22 The Planning Commission discussed the Conditional Use Permit and Design
23 Review Requests and made the following the comments and/or direction to staff:

- 26 • Requested more information on the potential for outdoor dining given the
27 plans showed foliage in that area, expressed concern with safety, and if
28 the area was converted to an outdoor patio more than foliage would be
29 required to prevent accidents from vehicles parked in the area.
30 (Martinez-Rubin)
 - 31 • Clarified with staff the potential for a request for outdoor dining would
32 result in the removal of some landscaping; a Landscape Plan had been
33 approved as part of the approval of the Pinole Shores Business Park; there
34 was no guarantee the Pinole Shores Owners Association would grant
35 approval for an outdoor dining area, but if consent was obtained from the
36 property owner, the City would work to ensure the preservation of as much
37 of the existing landscaping as possible. (Wong/Brooks)
 - 38 • Supported investment in new businesses; and supported the application
39 as is, while recognizing the real issue was around the sale of alcohol
40 rather than the signage or outdoor patio area. (Hartley)
